## **TERMS OF USE AGREEMENT**

**PLEASE READ THIS LICENSE AGREEMENT ("LICENSE") CAREFULLY BEFORE USING THE MUDBRICK MEDIA PRODUCT. BY USING SAID PRODUCT, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT USE THE PRODUCT.**

The media files / product, covered by this License whether on disk, in read only memory, on any other media or in any other form are licensed, not sold, to you by MudBrick Media (MudBrick) for use only under the terms of this License, and MudBrick reserves all rights not expressly granted to you.

You own the media on which the Files/Products are recorded but MudBrick retains ownership of the product itself.

The terms of this License will govern any upgrades that replace and/or supplement the original product, unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

**2. Permitted License Uses and Restrictions.** A. This License allows you to install and use the product. You may not make the product available over a network where it could be used by multiple computers at the same time. You may make copies of the product in machine-readable form for backup purposes only. Except as and only to the extent expressly permitted in this License or by applicable law, you may not copy, decompile, reverse engineer, disassemble, modify, or create derivative works of the product or any part thereof.

**3. Transfer.** You may not rent, lease, lend, redistribute or sublicense the product.

**4. Termination.** This License is effective until terminated. Your rights under this License will terminate automatically without notice from MudBrick if you fail to comply with any term(s) of this License. Upon the termination of this License, you shall cease all use of the product and destroy all copies, full or partial, of the MudBrick Product.

**5. Limited Warranty on Media.** MudBrick warrants the media on which the product is recorded and delivered by MudBrick to be free from defects in materials and workmanship under normal use for a period of ninety (90) days from the date of original retail purchase. Your exclusive remedy under this Section shall be, at MudBrick's option, a refund of the purchase price of the product containing the product or replacement of the product which is returned to MudBrick. THIS LIMITED WARRANTY AND ANY IMPLIED WARRANTIES ON THE MEDIA INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, OF SATISFACTORY QUALITY, AND OF FITNESS

FOR A PARTICULAR PURPOSE, ARE LIMITED IN DURATION TO NINETY (90) DAYS FROM THE DATE OF ORIGINAL RETAIL PURCHASE.
